- 1. Bec Need new walkie talkies for the competitions. Jackie to investigate.
- 2. Bec Under 13's prizes. Certificates might just add to the admin on the day. Jackie to organise chocolates for each time. Andy to look at a "Token" medal from a local supplier.
- 3. Alfern Reward the athletes and volunteers, how are we supporting our community. Look at hosting a Christmas party for council members and competition volunteers.
- 4. Alfern -WWA to host Sports Integrity Australia (SIA) for seminars and perhaps other education nutritionist seminars. Multiple venues, north & south. This is a measure of return for the members, all would be welcome.
- 5. Alfern post on instagram and email regarding lifting suits to be worn at comps, advertise external links to purchase suits.
- 6. Matt Too many people in the warm up room, the congestion needs to be addressed for safety as much as sanity. Lifters to be given wristbands on weigh in; according to IWF ratios. Jay to advise club reps of the new protocol. Athletes to advise who their coaches are at weigh in time coaches must be WWA members for insurance. ALL people in the warm-up must be WWA members. At each comp weigh in Jay to print a list of current Members.
- 7. Matt. Coach Education Subsidy. Reopens in September; for rural/regional coaches, to attend education sessions. e.g. Unit VIII
- 8. Bam 2022 national invitational run as a pre-nationals warm-up event with prize-money and sponsorship. Invitations based on AWF grading, based on Sinclair. Male/Female. Senior, Junior. Andy to speak with Nav for Flex Fitness sponsorship.
- 9. State training sessions coaches and athletes need to be given a more explicit structure e.g. athletes need to arrive with a training program and coaches need to coach other athletes than their own so that the team environment is developed. Head coach to brief the coaching staff of expectations and roles prior to the training session.
- 10. Coach selection policy adding in contingency for a chaperone for female lifters.
- 11. Andy to investigate whether SIA can present a talk at each training session.
- 12. Lifting suits Lifters to wear a generic or club coloured suit **not** a WWA suit unless they have represented WWA.
- 13. Andy transport for nationals. WWA to cover the costs of hiring a minibus for unaccompanied lifters.
- 14. Andy team dinner not possible due to the size of the team. WWA to cover the cost of pizzas for the whole team after the last session 26/6/21.
